Interim Town Administrator James O'Mara recognized State Reps Ronald Mariano and Mark Cusack for assistance with the Town receiving \$50,000 from the Executive Office of Public Safety for public safety, pending approval of the spending plan. A letter will be sent thanking Reps. Mariano and Cusack.

Town Accountant Bethiny Moseley and Superintendent of Public Works Christopher Pellitteri reviewed the history of the Water and Sewer Enterprise Funds. It was explained that the water and sewer accounts have been underfunded in FY19 and FY20, and 1%-2% increases are not keeping up with the expenses. The water expenses have been increasing, mainly due to debt, which is a stain on the fund. Mr. Pellitteri explained that they looked at other towns and how they structure their charges. The unmetered accounts need to be adjusted by 5% to reflect an accurate usage. And, other towns have established a base fee for water and sewer to cover costs. The lowest base quarterly fee that should be added to Sewer has been determined to be \$5.00, and the base quarterly fee for Water is recommended at \$23.00. The Sewer Fund would then be fully funded, but \$145,000 of retained earnings would still need to be used at town meeting to supplement the FY21 Water Enterprise account. The new base fees

would total \$112 per water/sewer customer per year, and follows suit with Braintree and Randolph. A 5-year outlook should be completed for stability in the rates. There will be a public hearing held at an upcoming meeting. If the accounts have a deficit, the deficit will go to the tax levy. Using retained earnings to fund the account is putting a bandaid on the problem.

Town Accountant Moseley explained that the Department of Revenue wants towns to have a 1/12<sup>th</sup> budget in place in case a town budget for next fiscal year has not been approved by July 1<sup>st</sup>. Information has been sent out to the Town departments. The 1/12<sup>th</sup> budget prepared by Ms. Moseley was reviewed. Town meeting is scheduled for June 24<sup>th</sup> and will potentially be held in the main parking lot at Holbrook Middle High School. The town election will be held on June 27<sup>th</sup> inside the school building.

1/12<sup>th</sup> budget plan as submitted by the Town Accountant, totaling \$6,007,451.65, for the General Fund, and including the Joint Water expenses of \$153,719, Water Enterprise of

\$465,030, Solid Waste Enterprise of \$57,446, and Sewer Enterprise of \$210,188

Wayne Darragh, the President of Community Opportunities Group, spoke about including Holbrook in a grant application he is writing for funding becoming available for Community Development Block Grants (CDBG) as part of the CARES Act. With Rockland as the lead community, the towns of Abington, Avon, Hull, Wareham, and Holbrook could join together with a grant application for

assistance to micro enterprises, together with a social service component to assist those affected by the COVID-19 virus, like providing additional funding for food pantries. There is a lot of competition expected, and the Dept. of Housing and Community Development has signaled that regional applications are more favorable. The Town would hear in July whether the grant has been approved.

application being prepared by Community Opportunities Group, Inc. for Community Development projects through DHCD and the federal CARES Act, including grants to businesses defined as micro-enterprises (5 or fewer employees, including the owner) and/or funding to support public social services activities designed to assist persons who

have been impacted by the COVID-19 virus

Mr. Pellitteri reported that recently there was a sudden drop in the water pressure that will be discussed at an upcoming water board meeting.

Board members spoke about creating an open space and recreation committee, a master plan, and a community preservation commission.

Discussion took place about opening the public parks. Katie Goldrick, Chairman of the Board of Health said that there is a tremendous amount of caution on parks, and playgrounds are not allowed to re-open at this point. Chairman Lee said the Sumner and Brookville gates should be open for use of the fields and the walking track, and caution tape should be wrapped around the swings. It was discussed that notice needs to be given to residents about what is allowed. Chief Smith said green tarps can be used over the playground equipment and other towns are putting a couple of 2x4's at the top of the basketball hoops. Ms. Campanella said that tarps would be a safety issue. A couple of signs will be hung on the fence and gate.

Mr. Reilly asked that the ballfields working group be consulted on the suitability for open space, which should be incorporated into the master plan. All of the Town's open space should be assessed for the plan.

Mr. Pellitterri reported that Republic Services had issues this week with their equipment. They missed some stops and people should call the office with their address if they were missed. They have not been able to put on a second truck lately, due to the increase in volume in other towns.

Mr. O'Mara announced that residents 60 and over should call the Council on Aging if they would like to receive frozen meats available from South Shore Elders.

Mr. Pellitteri said that there are significant costs associated with the processes that have been looked at to reduce PFAS at the treatment plant. They will be getting together with the engineers about where they are and the DEP guidelines. We are testing at 26 and test consistently while trying to filter it down. Mr. Lee asked that the numbers be reported when available.
