There is a fundraiser for the party to be held in two years, when the Town celebrates its 150th birthday.

It was explained that the Town has received a one million dollar grant from the state for work on Lake Holbrook Dam.

Dollar Grant from the Mass. Executive Office of Energy and Environmental Affairs, to be used for the repair of the Lake Holbrook Dam, authorize the expenditure of the funds,

Citizen Comments:

Mr. Greg DeLuca asked about the Lake Holbrook Dam project, which will include a bridge walkway. Ms. Lisa Paulson commented on the end of Sherrick Ave. where a landowner is building new homes, and said that she did not want the roadway becoming a through way, that the areas that were flagged have had the markings disappear, and there is water from over-saturation. Mr. Lee spoke in opposition to creating a through way on Sherrick Ave. Selectman Vayda spoke about the need to fill the position of Conservation Agent. Mr. Leo Eliasson said that the wetlands are being assessed as buildable lots, allowing the builders to build there.
