Resident and Chairman of the Friends of the Town Forest, Patricia Greely, said that the "32" off Weymouth Street has been sold, with no notice to the Conservation Commission. She located information on what should be done about the property and will send a link to the Town Administrator. Mr. Reilly also indicated that there is a need to fill the position of Conservation Agent.

Chief Smith came forward and introduced Police Officer Michael Szczesny, a new recruit on the Department. Town Clerk Jeanmarie Tarara swore Officer Szczesny in to the position, with his family and fellow officers in attendance.

Class II Auto Dealers License Hearing:

William Sheridan, President of Sheridan Automotive, Inc., was present. The legal notice, published in the Journal-Sun on February 5, 2020, was read.

Mr. Sheridan explained that he would like to be able to have 2-4 cars available for sale on his lot, so that he can accommodate his customers who would like to sell their cars.

Ms. Kathleen Chisholm of 411 North Franklin Street, an abutter, expressed a concern about how many cars would be there, and where and when. She said she has no problems with the business yet, but is concerned because there is no fence, and people might come to look at the cars at night. She wanted to know who would watch the conditions if the license is granted. It was explained that the Director of Inspectional Services would be the person overseeing it, and that the cars would be stored in the right front part of the property. The hours of the repair shop will remain the same as they currently are.

Director Erskine explained that he received complaints about the condition of a Town-owned parcel and sent a notice to Mr. William Nichols and Ms. Ellen Foulsham, the owners of 22 Newton Ave., directing them to remove their items from the property at 18 Newton Ave., and to cease using the property as their own. Mr. Nichols told him that they have been trying to purchase the property from the Town, but the property has to go to auction. Treasurer/Collector Digirolamo said that the property has gone up for auction twice, the last time on July 15, 2015, but the abutters said the minimum price was too high. They were only willing to pay \$5,000 for the 4,290 sq. foot lot. Mr. Digirolamo was asked to compile a list of properties that can be auctioned. Resident Roberta Mankus spoke about the beauty of the bees, birds and gardens on the property. Mr. Erskine said the appearance would be better with the boat, trailer, shed and belongings gone. Mr. Lee was concerned about the liability the Town has of someone being hurt on the property.

The Conservation appointment will be moved to another agenda, after the Conservation Commission has been able to consider the letters of interest and made a recommendation for appointment. The position will be reposted until the Friday before the next Conservation meeting.

Mr. Digirolamo explained that he is asking for authorization to enter into a lease with Pitney Bowes for the postage machine. The lease is less expensive than the previous one.

MOTION: By Ms. Vayda, second by Mr. McGaughey, that the Board of Selectmen authorize the

Town Treasurer to execute a 60-month lease with Pitney Bowes for the lease of the

postage machine at \$119.44 per month

VOTE: 3:0:1 (Mr. Reilly abstained)

Mr. Digirolamo said that he will be asking for approval of borrowing at the next meeting, for the Public Safety Building improvements and the Tri Town Water Treatment Plant.

Mr. Erskine reported that Tractor Supply fell a little short of their goals during the opening. Set Point RX is in the rough stage; Family Dollar and Dollar Tree are a couple of months out on opening. There have been 60 building permits this year. The new permit fee schedule will be going up on the website and effective April 1st.

Chief Smith reminded everyone about the new hands-free cell phone law, and reported that the Dana Farber blood drive is this Saturday at the Police Station from 8:30 am to 2:30 pm.

Director Hooke said that he has been working hard on the grant and the roof trusses are going up over the administration section of the new Communications building.
