Mr. Gordon reported that:

• The Veterans' Agent's position has been posted

- There is a meeting with Randolph coming up to discuss the financing for emergency repairs
- He recognized the Public Works Department for their work on Mary Wales Holbrook Park and getting ready for Memorial Day

Mrs. Brennan announced that the Norfolk County Sheriff has invited all seniors, and the Board of Selectmen, to a barbeque at Holbrook Court on July 9th at noon. It was also announced that Mrs. Barbara Moriarty is the Triad Liaison for the Council on Aging.

Board members discussed the responses to the Request for Proposals issued for the sale of the former South School at 719 South Franklin Street. Mr. Reilly said the Board needs to think about the future of the Town and which project would be a better fit at that location.

Town Owned Real Estate, known as the Former South School, located at 719 South Franklin Street, from Properties R.E. Company, Inc., at a bid price of \$1,010,000.

The Board considered the renewal agreement for the SoftRight accounting software, as requested by Town Accountant Bethiny Moseley.

Ms. Pamela Vayda reported that Holbrook Cares applied for a \$10,000 innovation grant which will be used for youth prevention work with middle-high school age students. Events will be held throughout the community from October 7 - 11, 2019. The Greater Brockton Health Alliance and Signature Health will be conducting focus groups to see what the community's needs are. They would like 10-20people to attend a meeting at 6:30 pm on July 16th. The Selectmen were invited to participate.

An update on the solid waste program for FY20 was given. Mr. Gordon said prices are being received for barrels, and there will be a town meeting article to fund the purchase of an estimated 2,800 barrels to provide to the residents in the program. A senior discount was discussed. Supt. Pellitteri said they are looking at a 32 gallon commercial grade barrel with a lid. There are 2,300+ residents using the trash program. There will be a discussion and vote on the program on July 10th.

The Inspectional Services Director's position has been posted, and interviews will be conducted after July 10th.

A special town meeting must be held in the early fall in order to appropriate the funding for the emergency repairs at the Joint Water Treatment Plant.
