2. Discussion/Vote – PFAS Mitigation Account Creation and Funding

TA Hanley introduced for Board discussion and possible vote a request to create the Town of Holbrook PFAS Mitigation Fund. After a brief discussion, Motion by Member Watkins to approve the creation of a PFAS Mitigation Fund authorizing \$1500. in funding to be provided funds from available ARPA funds. Seconded by Member Reilly by Roll Call Vote Unanimously voted 4-0

3. Discussion/Vote – Board of Health – Covid-19 Test Kit Payment Authorization from ARPA Funds Board discussion on the request of BOH

TA Hanley introduced for Board discussion and possible vote the request of BOH Chair Katherine Goldrick to procure 5000 COVID-19 testing kits from available ARPA funds. After a brief discussion, Motion by Member Watkins to approve the request from the BOH to purchase of Covid-19 Test Kits authorizing \$31,500 in funding to be provided funds from available ARPA funds. Seconded by Member Reilly by Roll Call Vote Unanimously voted 4-0.

4. Discussion/Vote – Holbrook Housing Authority Vacancy Appointments

TA Hanley introduced for Board discussion and public announcement on the need to appoint, on an interim basis, Holbrook Housing Authority Commissioners to serve on the HA Board until either a Gubernatorial Appointment or next election occurs. No vote necessary. Public Posting to follow
