The Town of Holbrook Board of Health is sponsoring a Household Hazardous Waste Pickup on Wednesday, July 7th, 2021. This will be a mobile non-event. **Waste pickup services will be performed on July 7th, 2021 between the hours of 7am and 5pm.** 

All waste items should be placed outdoors the morning of the pickup in a secure location (ex: Outside Garage Door, or On Front Porch). Residents must store waste items in a manner that prevents spills/ releases of hazardous waste to the environment.

DO NOT place waste items on the sidewalk or curbside - items must remain at or near the residence. DO NOT place materials outside for pick up prior to the morning of the pickup date.

Waste pickup service is available to residents of the town of HOLBROOK only. Residents may discard up to 25 gallons or 25 pounds (which is less) of household hazardous waste items during the pickup event. Residents SHOULD NOT mix chemical waste items together - this is dangerous and could result in injury. Residents must present waste items to ACV Enviro waste pickup staff in closed / sealable containers (example: buckets of oil with loose-fitting lids are not acceptable). ACV Enviro is not responsible for property damage resulting from hazardous waste spills that occur before ACV Enviro accepts custody of the discarded materials

What will be accepted:

- -Oil Paint, Paint Thinner, Lacquers, Wood Stains
- -Batteries (Lithium, NiCad- NO Alkaline)
- -Batteries (Car-Sized)
- -Oil

- -Gasoline, Lighter Fluid, Kerosene, Other Fuels
- -Other Automotive Fluids (i.e., Antifreeze)
- -Grease
- -Pesticides, Herbicide Liquids and Solids
- -Pool Chlorine Tablets and or Powders
- -Acidic Cleaning Products (i.e., muriatic acid)
- -Caustic Cleaning Products (Bleach, Ammonia, etc.)
- -Aerosol Products (i.e., Paint, Cleaners, Pesticides)
- -Chlorinated Solvents
- -Wax (Car, Floor)
- -Driveway Sealant
- -Paint/Wood Strippers
- -Oil/ Solvent-Soaked Rags

What will NOT be accepted:

- -Latex Paint
- -Florescent light bulbs 4 ft, 8 ft tubes, U-Tubes, Circle Tubes
- -Compact florescent bulbs (CFLs)
- -Alkaline batteries
- -Electronics (TVs, Monitors, Computers, etc.)
- -Fire extinguishers
- -Compressed Gas Cylinders
- -Propane Cylinders
- -Ammunition / Explosives / Road Flares
- -DEA-Controlled Drugs / Narcotics/ Medications
- -Radioactive compounds
- -Smoke Detectors
- -Friable asbestos (ex. insulation)
- -Blood / Bodily Fluids
- -Mercury
- -Syringes / Hypodermic Needles

- -Tires
- -Common Household Trash / Recyclables
- -Waste Items Originating from Non-Residential Locations
- -Unknown / Unidentified Chemical Items
