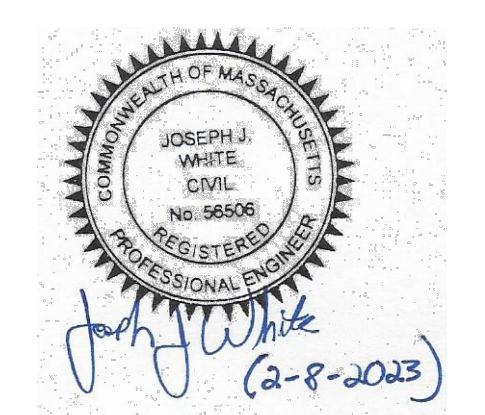


GENERAL NOTES:

1. SEE NATIONAL GRID ENVIRONMENTAL GUIDANCE AND DETAILS INCLUDED IN NOTICE OF INTENT SUBMITTAL PACKAGE FOR BEST MANAGEMENT PRACTICE DETAILS AND GUIDELINES FOR TEMPORARY CONSTRUCTION MATTING.
2. EXISTING POLES TO BE REMOVED INCLUDE POLES 236-243 AND 301-309.
3. EACH DISTRIBUTION POLE INSTALLATION TO INCLUDE EROSION & SEDIMENT CONTROL MEASURES AS SHOWN ON NATIONAL GRID ENVIRONMENTAL GUIDANCE DOCUMENT EG-303NE PAGE 7-15.
4. THE PROPOSED STRUCTURE LOCATIONS FOR #305, #306, #240 AND #240-50 ARE ADJACENT TO AN EXISTING BORDERING VEGETATED WETLAND AND CERTIFIED VERNAL POOL. THE LIMITS OF THE EXISTING WETLAND AND VERNAL POOL SHALL BE DELINEATED PRIOR TO CONSTRUCTION AND NO EQUIPMENT AND/OR UN-PERMITTED DISTURBANCE SHALL BE ALLOWED WITHIN THE RESOURCE AREAS.
5. DEWATERING BASINS TO CONFORM TO STANDARDS OUTLINED IN NATIONAL GRID ENVIRONMENTAL GUIDANCE DOCUMENT EG-303NE PAGE 7-38.
6. LIMITS OF TREE CLEARING IN BUFFER ZONES AND RESOURCE AREAS SHALL WITHIN THE LIMITS OF THE PROPOSED ELECTRICAL EASEMENT/RIGHT OF WAY OR TO ACCESS EXISTING EASEMENT FOR EXISTING POLE REMOVAL. GRUBBING AND/OR STUMP REMOVAL IS NOT PERMITTED WITHIN RESOURCE AREAS.
