PROPOSED ARTICLE MOTIONS

Article 1 – Unpaid Bills from Prior Fiscal Years

MOTION: I move that the Town transfer the sum of Ten Thousand Seven Hundred Seventy-Five Dollars and forty-eight cents (\$10,775.48) from Funding Sources already appropriated for the fiscal year ending on June 30, 2021, in order to provide for the payment of unpaid bills from fiscal years 2019 and 2020, as printed in the warrant.

FinCom recommendation: Motion to approve Unpaid Bills from Prior Fiscal Years (8-0-0)

Article 2 – Supplemental Appropriations

MOTION: I move that the Town transfer the additional sum of Two Hundred Thousand Dollars and zero cents (\$200,000.00) from Free Cash to Reserve Fund account 01-132-5200-5790 to supplement the original budget as voted at Town Meeting in June 2020.

FinCom recommendation: Motion to approve Supplemental Appropriations (8-0-0)

Article 3 – Reduce the Fiscal Year 2021 Tax Levy

MOTION: I move that the Town transfer the sum of Three Hundred Thousand Dollars and zero cents (\$300,000.00) from Free Cash, said sum to be applied to the reduction of the Fiscal Year 2021 tax levy

FinCom recommendation: Motion to approve Reduce the Fiscal Year 2021 Tax Levy (8-0-0)

Article 4 – Water Retained Earnings Usage

MOTION: I move that the Town transfer One Hundred Seventy-Nine Thousand Dollars and zero cents (\$179,000.00) from FY20 Certified Water Retained Earnings, to be a funding source for FY21 Water Enterprise Fund appropriations.

FinCom recommendation: Motion to approve Water Retained Earnings Usage (8-0-0)

Article 5 – Transfer Balances in Closed-Out Capital Projects to Capital Stabilization

MOTION: I move that the Town transfer the remaining balances in closed out capital projects, as indicated in the warrant, and that the sum of Four Thousand, Seven Hundred Seventy-Seven Dollars and Thirty-Two Cents (\$4,777.32) be added to Capital Stabilization, in order to be utilized for future projects.

FinCom recommendation: Motion to approve Transfer Balances in Closed-Out Capital Projects to Capital Stabilization (8-0-0)

Article 6 – Appropriate from Receipts Reserved for Appropriation for General Road Maintenance

MOTION: I move that the Town appropriate Four Thousand, Eight Hundred Eighty-Nine Dollars and Thirty Cents (\$4,889.30) from Receipts Reserved for Appropriation, Account 26-400-2680-5961, said

amount allotted by the Commonwealth Transportation Infrastructure Fund, to be transferred to the general fund to be used for General Road Maintenance.

FinCom recommendation: Motion to approve Appropriate from Receipts Reserved for Appropriation for General Road Maintenance (8-0-0)

Article 7 – Rescind Vote to Adopt Sewer Bank

MOTION: I move that the Town rescind the vote taken under Article 3 of the Annual Town Meeting held on June 19, 2006, which provided for the creation of a Sewer Bank.

FinCom recommendation: Motion to approve Rescind Vote to Adopt Sewer Bank (8-0-0)

Article 8 – Authorize Borrowing for Improvements at the Public Safety Building - Exterior

MOTION: I move that the Town appropriates \$396,000 to pay additional costs of making extraordinary repairs to the exterior of the Public Safety Building, including, but not limited to, replacing the exterior siding, trim and downspouts, which amount shall be expended in addition to the \$543,000 previously appropriated for this project by vote of the Town under Article 12 of the Warrant at the Annual Town Meeting held on May 7, 2019, and that to meet this appropriation, the Treasurer, with the approval of the Board of Selectmen, is authorized to borrow said amount under and pursuant to M.G.L. c. 44, §7(1), or any other enabling authority, and to issue bonds or notes of the Town therefor. Any premium received upon the sale of any bonds or notes approved by this vote, less any such premium applied to the payment of the costs of issuance of such bonds or notes, may be applied to the payment of costs approved by this vote in accordance with M.G.L. c. 44, §20, thereby reducing the amount authorized to be borrowed to pay such costs by a like amount.

FinCom recommendation: Motion to vote at Town Meeting: Authorize Borrowing for Improvements at the Public Safety Building - Exterior (8-0-0)

Article 9 – Authorize Borrowing for Improvements at the Public Safety Building - Interior

MOTION: I move that the Town appropriates \$100,000 to pay costs of remodeling and making extraordinary repairs to the interior of the Public Safety Building, and that to meet this appropriation, the Treasurer, with the approval of the Board of Selectmen, is authorized to borrow said amount under and pursuant to M.G.L. c. 44, §7(1), or any other enabling authority, and to issue bonds or notes of the Town therefor. Any premium received upon the sale of any bonds or notes approved by this vote, less any such premium applied to the payment of the costs of issuance of such bonds or notes, may be applied to the payment of costs approved by this vote in accordance with M.G.L. c. 44, §20, thereby reducing the amount authorized to be borrowed to pay such costs by a like amount.

Article 10 – Assistance to Firefighters Grant (AFG) – Town's Share

MOTION: I move that the Town transfer the sum of One Million, Thirteen Thousand One Hundred Forty-One Dollars and zero cents (\$1,013,141.00) from Free Cash, said sum to be used to add Three Hundred Thirteen Thousand One Hundred Forty-One Dollars and zero cents (\$313,141.00) to the General Stabilization Fund and to add Seven Hundred Thousand Dollars and zero cents (\$700,000.00) to the Capital Stabilization Fund, as established in accordance with the provisions of Massachusetts General Laws Chapter 40, Section 5B

Article 19 – Compensated Absences Fund
